## Overview

The City and Borough of Wrangell, hereinafter referred to as the OWNER, invites sealed bids for the supply of Park Benches and Trash Receptacles, on a one-time basis. The successful Bidder shall furnish and deliver the product to Wrangell, Alaska.

Sealed bids will be received by the City and Borough of Wrangell, Post Office Box 531, Wrangell, Alaska 99929, or located at the Borough Clerk's Office, 205 Brueger Street, Wrangell, Alaska 99929, until 2:00 PM prevailing time on June 24, 2014. The Bids will be publicly opened and read at 2:00 PM on June 20, 2014 in the City and Borough of Wrangell's Assembly Chambers in Wrangell, Alaska.

All bids must be submitted in sealed envelopes bearing on the outside the name of the project for which the bid is submitted. It is the sole responsibility of the Bidder to see that his bid is received in proper time. Any bids received after the scheduled closing time for receipt of bids will be returned to the Bidder unopened.

## Instructions to Bidders

1. Bids should include a full description and brand name of the material being offered. All prices should be FOB Destination, Wrangell, Alaska.
2. Bids must be typewritten or completed with pen and ink, signed by the Bidder or their authorized representative, with all erasures or corrections initialed and dated by the official signing the Bid. Bids are to remain firm for a minimum of sixty (60) days.
3. Submit Bids plainly marked with "Park Benches and Trash Receptacles, City and Borough of Wrangell."
4. Modifications to Bids. Any Bidder may modify his bid by submitting a written modification signed by the Bidder. Modifications may be either hand delivered (205 Brueger Street, Wrangell, AK 99929), mailed (P.O. Box 531, Wrangell, AK 99929), faxed (Fax: 907-874-3952), or emailed (clerk@wrangell.com), provided such communication is received by the OWNER prior to the bid closing time. Modifications should not reveal the bid price but should provide the addition or subtraction, or other modification, so that the final prices or terms will not be known by the Owner until the sealed bid is opened.
5. Addenda. Each bid shall include specific acknowledgment in the space provided of receipt of all addenda issued during the bidding period. Failure to so acknowledge may result in the proposal being rejected as not responsive.

6. The Bid Price shall include everything necessary for the fulfillment of the contract, including, but not limited to, furnishing all materials and equipment, except as may be provided otherwise in the Contract Documents. In the event of a difference between a price quoted in words and a price quoted in figures for the same bid, the words shall be the amount bid.

## Standards for Acceptance of Bids for Awarded Contract

The OWNER reserves the right to reject any or all bids, waive any informalities or irregularity in the bidding and/or not make an award. The award of the Contract, if made by the OWNER, will be made to the qualified and responsible Bidder submitting the lowest responsive bid, but the OWNER shall determine at its own discretion whether a Bidder is responsible and qualified to perform the Contract, and what bid is the lowest or in the best interest of the OWNER. "Best interest of the Owner" includes the OWNER's right to consider a potential substitute product design or any other matters to be submitted pursuant to the Contract Documents in making its determination, and determine whether it is to the best interest of the OWNER to accept the bid. The City and Borough of Wrangell reserves the right to modify the contract after its award.

## General Terms and Conditions

1. Specification Discrepancies: Any obvious error or omission in specifications shall not be to the benefit of the Bidder but shall put the Bidder on notice to inquire of or identify the same from the City and Borough of Wrangell. Whenever mention is made of any article, material, or workmanship to be in accordance with laws, ordinances, codes, underwriter's codes, A.S.T.M. regulations or similar expressions, the requirements of these laws, ordinances, etc., shall be construed to be the minimum requirements of these specifications.
2. Delivery Point: All items offered shall be on the delivery basis of FOB Destination: City and Borough of Wrangell, Wrangell, Alaska 99929. Delivery cost shall be included in the Bid price.
3. Delivery Time: All items shall be received within 90 days of the date of Bidder's receipt of a City and Borough of Wrangell purchase order; otherwise, Liquidated Damages in the amount of $\$ 250 /$ calendar day will be paid by the Bidder against the contract price.

## Description of Materials

Bids for materials and supplies should include a complete description, manufacturer's name, and manufacturer's specification data sheets, including optional materials and colors used to determine complete and final product.

## Quality

All materials used for the manufacture or construction of any materials or equipment covered by this Bid shall be new (unless otherwise specified as recycled or repurposed), of the latest model, of the best quality, and of the highest grade workmanship. It is the Bidder's responsibility to

prove to the City and Borough of Wrangell that each item offered is equal to the grade or quality of material specified.

## Acceptance of Material

The materials delivered under this Bid shall remain the property of the Bidder until a physical inspection and actual usage of this material and/or services is made and therefore accepted to the satisfaction of the City and Borough of Wrangell.

Warranty
All manufactured products shall be warrantied against defect in materials and/or workmanship and in accordance with these specifications. The manufacturer shall further warrant their products offered hereunder as follows:
A. Limited 20-year warranty against structural failure of all steel bench frames or complete steel bench assemblies and litter receptacle frames and all cast iron bench supports.
B. Limited 10 -year warranty against structural failure of recycled plastic. It is further warrantied not to degrade, split, crack or splinter during this 10-year period.
C. Limited 1-year warranty on any item not specifically mentioned above.

## Compliance with Specifications

Terms and Conditions: The Invitation to Bid, General Conditions, Instructions to Bidder, Specifications, Special Conditions, Bid, Addendum, and/or any other pertinent documents form a part of this Bid and by reference are made a part hereof.

## Park Bench and Trash Receptacle Specifications

The City and Borough of Wrangell requires 14-each park benches and 14-each trash receptacles with the following specifications: The basis of design for the products shall be DuMor Site Furnishings’ Bench 57 and Receptacle 124-31PL, or approved equal, meeting the minimum fabrication and design standards as follows:

## Park Bench

- DuMor Bench 57, Steel / Plastic Bench with Back Support, 6’-long.
- Cast Iron Steel Frame/Supports with rosette design.
- Steel member's coatings of zinc-rich epoxy primer, then finished with a TGIC-polyester powder coating, Green color to match Wrangell's existing street light poles (Sherwin Williams paint color powder\# PGS5-00522, was Fuller\# IF7725M WET \# F78XXG3237).
- Seat surface constructed with 2" x 3" recycled HDPE plastic slats with a wood appearance, Cedar color.
- Rated to support at least 229 lbs .
- Include all necessary surface mounting plates and expansion anchor bolts (for surface mount to concrete slab).
- Quantity: Fourteen (14) each


## Trash Receptacle

- DuMor Receptacle 124-31PL, Steel / Plastic Trash Receptacle, 3’-high.
- Steel Frame with rosette design at top of frame (to match bench rosette design)
- Steel member's coatings of zinc-rich epoxy, then finished with a polyester powder coating, Green color to match Wrangell's existing street light poles (Sherwin Williams paint color powder\# PGS5-00522, was Fuller\# IF7725M WET \# F78XXG3237).
- Exterior constructed with vertical 2" x 3" recycled HDPE plastic slats with a wood appearance, Cedar color.
- Receptacle cover shall include a bonnet top to keep the rain form entering the receptacle. Top shall be attached to the base by a vinyl-coated cable.
- Minimum 30-Gallon Capacity with Galvanized interior liner.
- Include all necessary surface mounting plates and expansion anchor bolts (for surface mount to concrete slab).
