## MAYOR/ASSEMBLY REPORTS AND APPOINTMENTS

10a Reports by Assembly Members

Decker reported on the House District status of votes and of how close they are. She reported on other statistics of the General Election as well.

#### PERSONS TO BE HEARD

**Stephen Cole, 5 Mile Loop Road,** spoke about the marijuana law issue and on some of the potential positive effects that it could have for the community of Wrangell. He asked the City not to throw roadblocks in the way of it.

Jack stated that he didn't see that the City would be passing an ordinance to ban marijuana however; that the City receives Federal funding so he didn't see the City supporting the issue either.

Blake stated that the products for producing it could not be shipped via boat or airplane since those forms of transportation were federally regulated.

### **UNFINISHED BUSINESS**

12a Approval of the Wrangell Capital Project Requests for FY 2015-16 (postponed from the October 28, 2014 Special Assembly Meeting)

M/S: Prysunka/Decker, to approve the Wrangell Capital Project Requests for Fiscal year 2015-2016, as presented.

Decker questioned why the number one project – Pool Facility Improvements – had a higher request amount than the actual project amount.

Jabusch stated that it was probably a mistake and would be corrected.

Blake stated that he would like to see the City rebuild the existing dam instead of running an underground water pipe from Sunrise Lake.

Motion approved unanimously by polled vote.

### **NEW BUSINESS**

13a Approval for Engineering Services and to purchase a new Digital Excitation System for the Light Plant

M/S: Decker/Prysunka, to approve purchasing a new Digital Excitation System from Bassler Electric for the Light Plant without competitive bidding as allowed under Wrangell Municipal Code 5.10.050 (F), and to also approve Electric Power Systems, Inc. to provide the engineering services for this project without competitive bidding as allowed under Wrangell Municipal Code 5.10.050 (E) with funds for the project to come from the current Light Fund budget.

Jabusch explained the need for this piece of equipment because it without fixing it, the generator would be very unreliable.

Blake stated that he had taken a tour with Clay of the Power Plant and that they generators were well taken care of by the plant workers; stated that this piece of equipment had some sort of defect and needs to be replaced.

# Motion approved unanimously by polled vote.

13b PROPOSED RESOLUTION No. 11-14-1307: A RESOLUTION OF THE ASSEMBLY OF THE CITY AND BOROUGH OF WRANGELL, ALASKA, VOIDING THE WARD REPLAT, PLAT #2008-3

M/S: Decker/Prysunka, to adopt Resolution No. 11-14-1307, that void's the Ward Replat, No. 2008-3.

In Response to Mitchell, Jabusch stated that the subdivision should have never been granted since Mr. Ward did not actually own the property. Jabusch said that he would talk with Economic Development Director Rushmore to take steps so that this would not happen in the future.

# Motion approved unanimously by polled vote.

13c Approval of a Budget Amendment in the Sanitation Collection Budget to purchase additional dumpsters

At the request of Mitchell, Carl Johnson explained the need for the additional dumpsters.

M/S: Blake/Mitchell, to approve a Budget Amendment to increase line item 34.01.00.5855 of the Sanitation Collection Budget from \$4,000 to \$10,000 with funds to come from the Sanitation Reserve Fund. Motion approved unanimously by polled vote.
