A total of six hundred-seven (607) ballots were used which included five hundred-ten (510) voted locally, eighty-four (84) absentee in person, absentee by mail, four (4) by special needs representative, zero (0) emergency, four (4) questioned, five (5) spoiled ballots, and zero (0) challenged ballots.

Zero (0) absentee ballots by mail were not returned, zero (0) absentee ballots by mail were returned late and were not counted. Eight (8) absentee by fax which were hand counted (not a numbered ballot) and are added. Three (3) questioned ballots were not counted and are subtracted, five (5) ballots were spoiled and are subtracted. A total of six hundred-seven (607) ballots were counted.

We, the undersigned Canvass Board, certify that the Election was validly held and the return accurately presented, and that no discrepancies or contingencies were found.


The foregoing Certificate of Results is a full report of votes cast for the Regular Election held October 2, 2012.


