In response to Assembly Member Decker, Harbormaster Greg Meissner stated that this Ordinance was to clarify the space limit for businesses that held leases with the City; he stated that if there was a business that had more than one space, that business would be grandfathered in and be allowed to continue carrying the multiple leases. He further clarified that if that business were to relinquish one of their leases, that business would then only be allowed to carry one lease.

**13e** Approval of a contract agreement for the annual Household Hazardous Waste Collection services

M/S: Blake/Decker, to approve proposed contract with Carson Dorn, Inc., without competitive bids as provided in Wrangell Municipal Code 5.10.050 (E), to provide services to collect and remove Household Hazardous Waste from Wrangell in an amount not to exceed \$14,000 with funding to come from budgeted funds in the Sanitation Department. Motion approved unanimously by polled vote.

**13f** Approval to award the proposal received from DOWL HKM for the Professional Engineering Services for the Sewer Pumps Replacement Project Design

M/S: Decker/Blake, to approve entering into an agreement with DOWL HKM for the Sewer Pump Replacement Project Design, on a time and expense basis not to exceed \$98,173.00 which is scheduled to be paid from the City and Borough of Wrangell's grant funds, provided by State of Alaska Department of Commerce, Community, and Economic Development. Motion approved unanimously by polled vote.

**13g** Approval to purchase residential property from Shelly Massin for the purpose of a right of way

M/S: Decker/Blake, to pay Shelley Massin for the ditch and power line easements based on the appraised value of the easements to be determined by our assessor and to also pay her for the purchase of 155 sq. ft. of road way on her property in the amount of \$387.50.

Borough Manager Jabusch stated that the Staff believes that Ms. Massin should be paid for the easement since this was the practice in the past; this started when Ms. Massin wanted to subdivide; our Assessor has a calculation on how easements are paid to property owners; it is not the practice to purchase the land; Staff's recommendation is to purchase the property as stated, for the right-of-way; an easement should be done for the ditch (which holds a waterline) and the power line on her property.

In response to Assembly Member McCloskey, Carol Rushmore, EDC Director stated that Ms. Massin had submitted the first exhibit to staff; there was a request for additional information by Staff; Greg Scheff then did a preliminary survey on the roadway and the ditch as per Ms. Massin's request. Mr. Scheff then calculated the area in the roadway and the ditch; that is how Staff came to the right-of-way determination.

In response to Assembly Member McCloskey, EDC Director Rushmore stated that this had not gone to Planning & Zoning yet because the plat that P&Z would consider depended on what the Assembly decided to do.

Ms. Massin stated that she would not be able to build 12 feet out from the power line.

M/S: Decker/Stough, to postpone this item until the next meeting on April 8th. Motion approved unanimously by polled vote.

The Assembly directed Manager Jabusch to find out the value of assessed value of the ditch, the value of the ditch area if the City were to purchase it, the property taxes for the easements, and the value of the electrical easement.





#### **RE:** Canadian Mine Development in Transboundary Watersheds

Dear Senator Murkowski, Senator Begich, and Representative Young:

United Fishermen of Alaska (UFA) is the statewide commercial fishing trade association, representing 36 commercial fishing organizations participating in fisheries throughout the state and its offshore federal waters. UFA has a strong interest in maintaining environmental values that provide for the sustainable harvest of Alaska's fishery resources. Development projects that have the potential to do irreparable harm to water quality and aquatic resources are widely opposed by our members. We write to make you aware of the risks posed by numerous existing and proposed mining projects in watersheds shared by British Columbia (B.C.) and Alaska.

Due to be completed in 2014, B.C.'s Northwest Transmission Line will facilitate large-scale mining in northwest B.C. At least a dozen industrial projects are planned in the headwaters of several transboundary rivers. Two primary concerns related to the massive B.C. mining boom are water quality impacts in Alaska and damage to salmon spawning habitat in B.C. The transboundary Taku, Stikine, and Unuk Rivers support significant fish and wildlife populations; all five species of salmon contribute heavily to sport, subsistence, personal use, and commercial fisheries.

The Unuk River is one of the top four king salmon producers in Southeast Alaska. The Taku River is Southeast Alaska's single largest producer of all species of salmon, and the largest producer of king and coho salmon. On average, 40% of the region's king salmon originate in

the Taku River. The Stikine River is also a heavy salmon producer and ranks second only to the Taku. The Taku and Stikine Rivers are the primary focus of the Transboundary Rivers annex of the Pacific Salmon Treaty, and provide for important fisheries in both Alaska and British Columbia.

There appears to be limited dialogue between Canada and the U.S. regarding mining development in B.C. No agreements are in place to ensure that Alaska's fishing and environmental interests will be protected in the face of B.C.'s fast expanding mining program. Canadian agencies have established joint working groups with Alaskan and U.S. agencies to review various mine proposals, but they are under no legal obligation to address U.S. or Alaskan concerns. Moreover, Alaskan and U.S. agencies lack the resources necessary to participate in these working groups in a meaningful way.

Given the enormous environmental and economic value of transboundary watersheds, the existence of bilateral conservation and harvest sharing agreements through the Pacific Salmon Treaty, and the absence of a functional plan to safeguard Alaska's downstream interests, we respectfully request you engage the U.S. State Department on this matter.

We urge you to ask the State Department to identify and employ mechanisms to ensure that Alaska water quality and fish and wildlife values will not be adversely affected by upstream industrial development in B.C.

#### Dear Secretary Kerry:

The proposed development of several hardrock mines in British Columbia has raised serious concerns regarding water quality in transboundary rivers that flow from Canada into Southeast Alaska. To ensure the valuable marine resources that contribute so much to the economy and culture of Southeast Alaska are protected, we request that you and other officials from the Department of State raise this issue in appropriate bilateral meetings with your Canadian counterparts.

As a delegation we are strongly supportive of responsible mining activities in Southeast Alaska such as the Greens Creek and Kensington mines. However, reports of proposed mining development in the Stikine, Taku, and Unuk River watersheds have raised concerns among commercial and recreational fishermen, tourism interests, and Alaska Native communities about maintaining the water quality of these transboundary rivers that flow by their homes and onto their fishing grounds.

Alaska has the world's most productive, sustainable commercial fisheries and Southeast Alaska is a major contributor. Southeast fishermen landed a record harvest of 95 million pink salmon in 2013. Combined with other species, the Southeast salmon catch was valued at nearly \$220 million for fishermen. Halibut, black cod, herring, and shellfish are also present in these waters. In total, the Southeast seafood industry produced \$641 million worth of fish in 2011, which created 17,500 jobs and \$468 million in wages.

Tourism brings almost two million visitors a year to Alaska, with about one million coming in via cruise ships through the waters of Southeast. Many are attracted by the recreational fishing opportunities for salmon and halibut. Visitors to Southeast Alaska spent \$1.1 billion in 2013, and created 10,900 jobs that generated \$407 million in income. The entire sector generated \$179 million in state and local revenues.

The commercial fishing and tourism industries are vital to Alaska's economy and proper steps must be taken on both sides of the border to safeguard them. In addition, Alaska Native communities throughout Southeast are dependent on these same fishery resources, marine mammals and waterfowl to meet their subsistence needs. Tlingit, Haida and Tsimshian traditions and culture are tied to the bounty from the waters of the archipelago. Their food security and very survival depend on keeping these waters healthy.

Water quality is an extremely important issue for Alaskans. Accordingly, we ask you and other officials from the Department of State raise these concerns with the governments of Canada and British Columbia. Doing so will help us gain a better understanding of the new development taking place across our border, ensure that appropriate environmental safeguards are in place for that development, and keep Alaska waters pristine and productive.



#### **BACKGROUND:**

The City and Borough of Wrangell contracted with R&M Engineering – Ketchikan to provide professional design services for the Cassair Street Roadway and Utilities Improvements Project. We generally exclude construction administration and inspection services from our engineering design contracts until the design is complete. Until that time, we cannot ensure the level of professional services needed.

With the project's design and bidding phases now complete and nearing construction commencement, the level of engineering services required for contract administration and inspection, beyond what staff can provide, have been identified.

R&M Engineering has reviewed the level of services requested of them and have provided a fee proposal to perform the contract administration and inspection work on a Time and Expense basis, not the exceed \$91,760.00. If approved, these services would be scheduled to be paid from grant funds provided by the State of Alaska Department of Commerce, Community and Economic Development (DCCED) and the State of Alaska ADEC.

#### **RECOMMENDATION:**

Staff recommends the Borough Assembly to issue a contract with R&M Engineering – Ketchikan based on Time and Expense and in the amount not to exceed \$91,760.00 for the Contract Administration and Inspection Services which is scheduled to be paid from the City and Borough of Wrangell's grant funds designated for this project.
