In 2016 number of crew member license holders 219.

For a family to benefit... nurse could keep job, but husband is affected. They should be eligible to apply. What about singles living together, they may have all been affected.

JD... \$500 first come first serve per HH... staff can keep putting money in there. Should be queued up to put money towards it.

BL.. likes that. Also do a program end date of Oct. 15 to reopen or reallocate funds if money is still available. Provide more incentive to get applications in.

JS Everything comes to a head on Nov. 1. Gives 2 months to get it out.

Should it be tied to utility bill?

Challenge will be when you have several individual in household we will not be able to verify same household. Household will have a physical address/with utility bill
