#### MAYOR AND ASSEMBLY BUSINESS

Prysunka reported that he signed onto a letter (along with other AK Mayors) that AML submitted on the Telehealth Legislation that went to the State Legislature and had provisions that extended the ability for doctors and nurse practitioners using Telehealth and lowered some of the hospital staff requirements; the

mining can be done, just needs to be done correctly; also to include that of all of the rivers that are at risk, Wrangell stands to be greatly impacted.

In response to Gilbert on how many communities have signed onto the Resolution that they provided, Ms. Walker stated that three communities, a number of tribal entities, and over two dozen businesses and organizations have signed on, again using the provided Resolution.
