# WRANGELL : COMMUNITY PROFILE

# LOCATION

Wrangell Island is located 90 miles north of Ketchikan in Southeast Alaska, near the mouth of the Stikine River. By air, Wrangell is approximately 1 hour 30 minutes (155 air miles) south from Juneau, and 3 hours from Anchorage and Seattle (just over 700 air miles each). The City of Wrangell is located on the northern tip of Wrangell Island.

## LOCAL GOVERNMENT

Wrangell is a Unified Municipality (Borough) with an Assembly- Manager form of government. On May 30, 2008, the City of Wrangell was dissolved and the City and Borough of Wrangell was incorporated. There is a seven member Borough Assembly and an elected Mayor.

The Borough has two tax structures, 12.75 mills for those within the Service Area; 4 mills for a Tax Differential Zone and for the remote areas.

Sales Tax is 7% on all goods and services.

Police Department has seven sworn officers. Fire Department has one full time salaried employee and 40 volunteers. There is a substation at milepost 5.5 on Zimovia Highway. ISO rating is 3.

### ECONOMY

Wrangell's economy, while historically based on the wood products and fishing industries, is now driven by tourism and marine industries.

Fishing and fish processing are a very important segment of the local economy. Fleets of shrimp, crab, troll, seine, gillnet, and trawler vessels are based in Wrangell. There are two seafood processors and a crab processor. The community completed marine several industrv has enhancement projects, includina recent the completion of a marine service and repair yard with two travel lifts to support the commercial and recreational boats transiting the Inside Passage.

Independent visitor tourism plays a major role during the summer months from May through September. Wrangell's Downtown Revitalization project to rebuild infrastructure and enhance the downtown commercial corridor is recently completed. The local Tlingit tribe completed reconstruction of Chief Shakes Tribal House. Fishing, hiking, museum, sightseeing, flightseeing and wildlife charters, petroglyphs and local art are available for independent travelers arriving by ferry or jet, yachts and cruise ship passengers.

Public sector employment is also a significant contributor to the local economy. This includes employees of the City and Borough of Wrangell, Wrangell School District, Wrangell Medical Center, local employees of state agencies including Health and Social Services, Fish and Game, Transportation and Public Safety; and local federal employees of the Postal Service, Customs and US Forest Service.

#### TRANSPORTATION

Wrangell is an island community and accessible by air and water.

*Air*: There is regular Alaska Airlines jet service from Seattle and Juneau. Local air charter services (fixed wing and float plane) are available.

*Water:* There is regular mainline passenger ferry service via the Alaska Marine Highway System from Bellingham WA, and Juneau. Regular barge service from Seattle area and Juneau is provided by Alaska Marine Lines and Samson Tug and Barge. There are also local marine freight haulers available.

**Port:** Borough operated port facilities include a T-shaped City dock for cruise ships and yachts, deep water port with barge facility, 2 marine travel lifts and work yard, seaplane dock, and three boat harbors. State operated facilities include an international airport and ferry dock.

*Truck:* Wrangell has several trucking companies hauling and shipping materials and goods including Arrowhead Transfer, Lynden Transport.

**Bus/Taxi/Rental Cars:** There is no regular community bus service, but is one taxi company. Senior Citizens have a van for transportation. Several tour companies have busses or vans available for charter. One car rental facility located at the airport.

#### COMMUNITY FACILITIES

*Health Care*: Local physicians provide medical services out of the new Alaska Island Community Services Clinic. Wrangell Medical Centre is an acute care hospital has 7 beds, participates in a visiting specialist physician program and houses a 14 bed long-term care unit. There is a State Health Clinic with a resident nurse practitioner. Wrangell has one dentist and one chiropractor.

*Education:* During the 2014-2015 school year, 272 students are enrolled in the district, with 30 certified instructors employed. Contact the District office for information on extracurricular activities or specific educational programs.

*Evergreen Elementary* is dedicated to providing hands-on learning experiences with reading, writing and math as core curriculum. *Stikine Middle School* serves students grades 6-8 and shares many facilities with the adjacent High School. *Wrangell High School* serves students grades 9-12. Specialized classes in tech prep and career oriented courses, and computer technology are popular classes to complement core curriculum courses.

*Irene Ingle Public Library:* The library boasts an outstanding collection of children and adult books, videos, books on tapes and computers, free internet and wi-fi usage and sponsors a summer reading program.

**Wrangell Museum and Civic Center:** The Museum is an interactive story of Wrangell's history with local and regional artifacts. Convention facility rentals are available. Current movies are scheduled regularly in the facility by Castle Mountain Inc.

Recreational Facility and Community Center:

Attached to the High School is a community recreational facility housing a swimming pool, weight room, racket ball court and public showers.

**Harbors:** There are three recreational and commercial fishing harbors. Reliance Boat Harbor is located in town and has 230 slips available with transient moorage space. Shoemaker Bay Harbor is located 5 miles from town with 250 slips. Heritage Harbor is 1 mile from town with 160 stalls and transient yacht moorage. Public boat ramps and hoists are located at each harbor. Summer floats at City Dock are for loading and unloading gear and passengers and for transient yachts.

**Campgrounds:** Overnight camping is allowed at City Park, located about one mile from town. There is also camping available for tents and 16 R.V.'s at Shoemaker Bay Harbor 5 miles from town. Dump station and water are available, with electrical to RV sites. Cost is \$15 and \$25. Primitive camping is provided at several US Forest Service campgrounds in Tongass National Forest on Wrangell Island for tents and RVs. The USFS also maintains 23 cabins in surrounding remote areas for public use on a reservation basis.

**Other recreational facilities and opportunities:** There is a skating rink, two tennis courts, basketball courts, indoor and outdoor shooting ranges, two baseball fields, golf course, year-round recreational programs, archery range, fishing, boating, biking, beach combing, children play equipment, petroglyphs, hiking trails, camping, hunting, cross-country skiing, snowmobiling, outdoor covered playground and track/multi-purpose field. There are over 100 miles of forest roads on Wrangell Island for access to lakes and scenic areas.

*General:* There are 11 churches, 2 banks-each with ATMs. The Visitor Center is located in the Nolan Center.

#### Water:

Supplier: City and Borough of Wrangell Water Service: 80 % of households within the Service Area are connected to the system. Water source: Two reservoirs, central piped water system. Ozone and sand filtered water filtration plant came online in July of 1999. Average Daily Consumption: 700,000 gallons/day Water Usage Rates: Flat monthly fee for service. Residential rate is \$38.44. Commercial rate is defined in the Borough Code by business type.

#### Sewer:

Supplier: City and Borough of Wrangell

Service: 80 % of the households within the Service Area are connected to sewer. The remainder have a state approved on-site treatment facility.

Sewer Treatment: New secondary treatment facility with a marine outfall.

Sewer Rates: Flat monthly fee for service. Residential rate is \$36.95. Commercial rate is defined in the Borough Code by business type.

#### Garbage:

Supplier: City and Borough of Wrangell.

Service: Garbage is picked up weekly and disposed of at a material recovery handling facility. Garbage is shipped south to a landfill.

Rates: Residential rate is by can size. 48 gallon can is \$26/mo; 64 gallon can is \$43.20/mo; and 96 gallon can is \$51.80/mo. Commercial rate is defined in Borough Code by business type.

#### COMMUNICATION

Telephone: Local supplier is Alaska Power & Telephone. Long distance is supplied by AT&T, AP&T or GCI Communication. Cellular phone service is provided by AT&T or GCI. Internet Access: Local dial-up, broadband and fiber optics. Broadband access is provided by AP&T; fiber optics is provided by GCI Communication.
