Individual members of an entity must submit their own comments in order to have eligibility to object as an individual. It is the responsibility of the sender to ensure timely receipt of any comments submitted. Names and contact information submitted with comments will become part of the public record and may be released under the Freedom of Information Act. Comments must be within the scope of the Proposed Action, and include supporting reasons for the Responsible Official to consider. The Responsible Official for this project is M.
