Use of Loaned Items

Unless otherwise notified in writing by the lender, the object(s) lent may be photographed by The Wrangell Museum for records, educational, catalog and publicity purposes, and may be made available for research by scholars.

Notification of Loan Termination and Forfeiture of Loaned Objects

Pursuant to AS Title 14, Chapter 57, Section 14.57.200 – 290, the museum may acquire title to loaned property if it meets the appropriate criteria. On or before the termination date as specified in this agreement, a Notification of Loan Termination will be sent to the lender. All notices will be sent by certified mail to the lender at the primary and secondary contact address given in this record, or at the address(es) the lender has subsequently provided to the museum. The lender will have thirty (30) days to respond, in writing, to the museum regarding the disposition of the loaned objects. If the lender does not respond to the Notification of Loan Termination within thirty (30) days of receipt, the museum shall then publish a notice once a week for four consecutive weeks in a newspaper of general circulation in the judicial district where the museum is located. If after forty five (45) days from the date of the last publication a valid claim is not made for the property, the museum will acquire title to the property. Acquiring title to the object(s) in no way obligates the museum to accession the object(s) into the permanent collection. The museum reserves the right to dispose of the object(s) when appropriate.

Unless otherwise notified in writing, The Wrangell Museum will release the object(s) only to the lender, or beneficiary in the event of the lender's death. Photo identification is required prior to taking possession of loaned items.

I understand and accept that notification of loan termination will occur in the manner stated above. My failure to respond to the Notification of Loan Termination and/or my failure to contact the Museum after one hundred and five (105) days of the loan termination should I not receive the Museum's notification indicates that it is my intent to donate the items described herein and in the attached itemized list (if any) to The Wrangell Museum.
