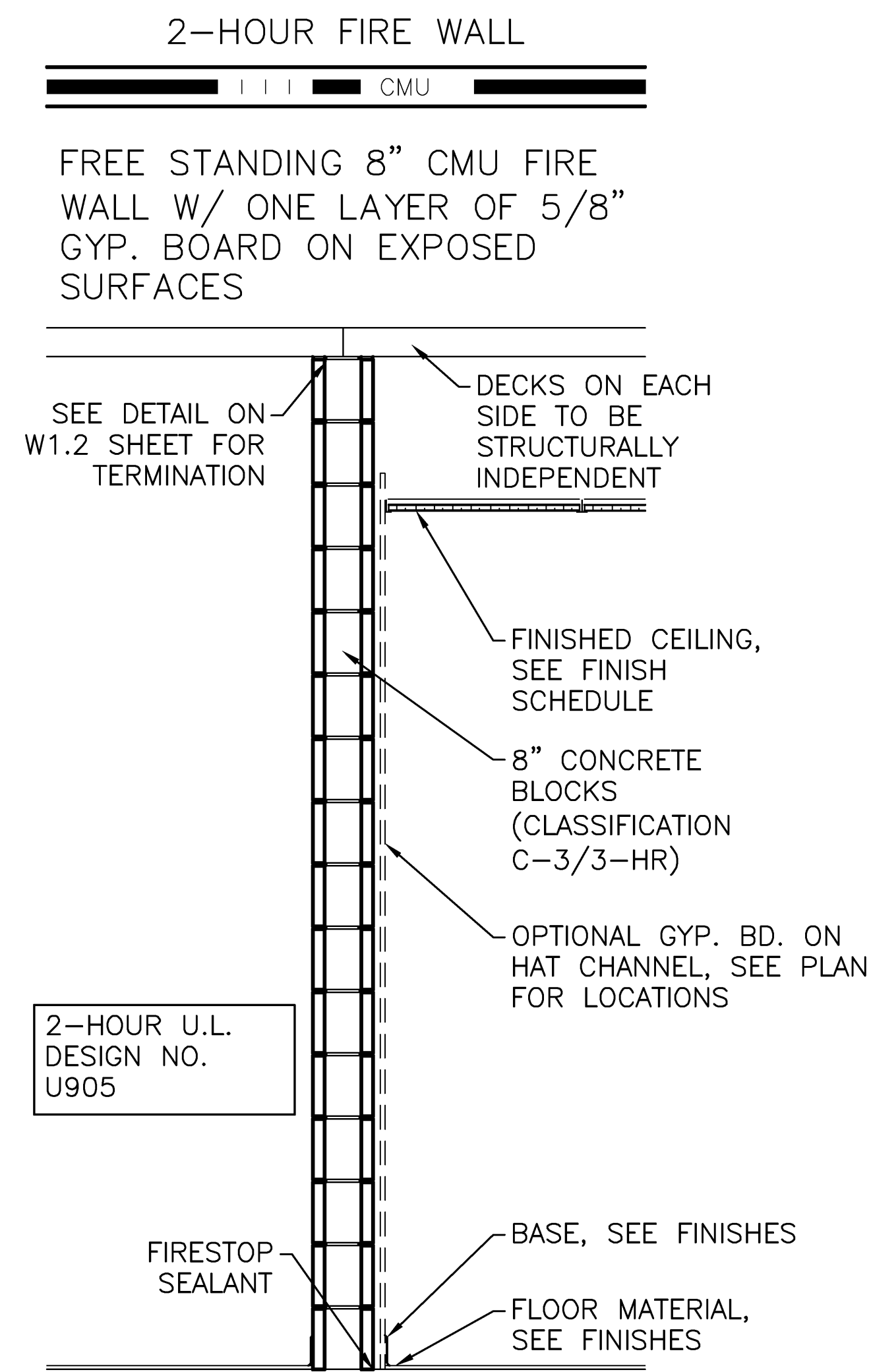

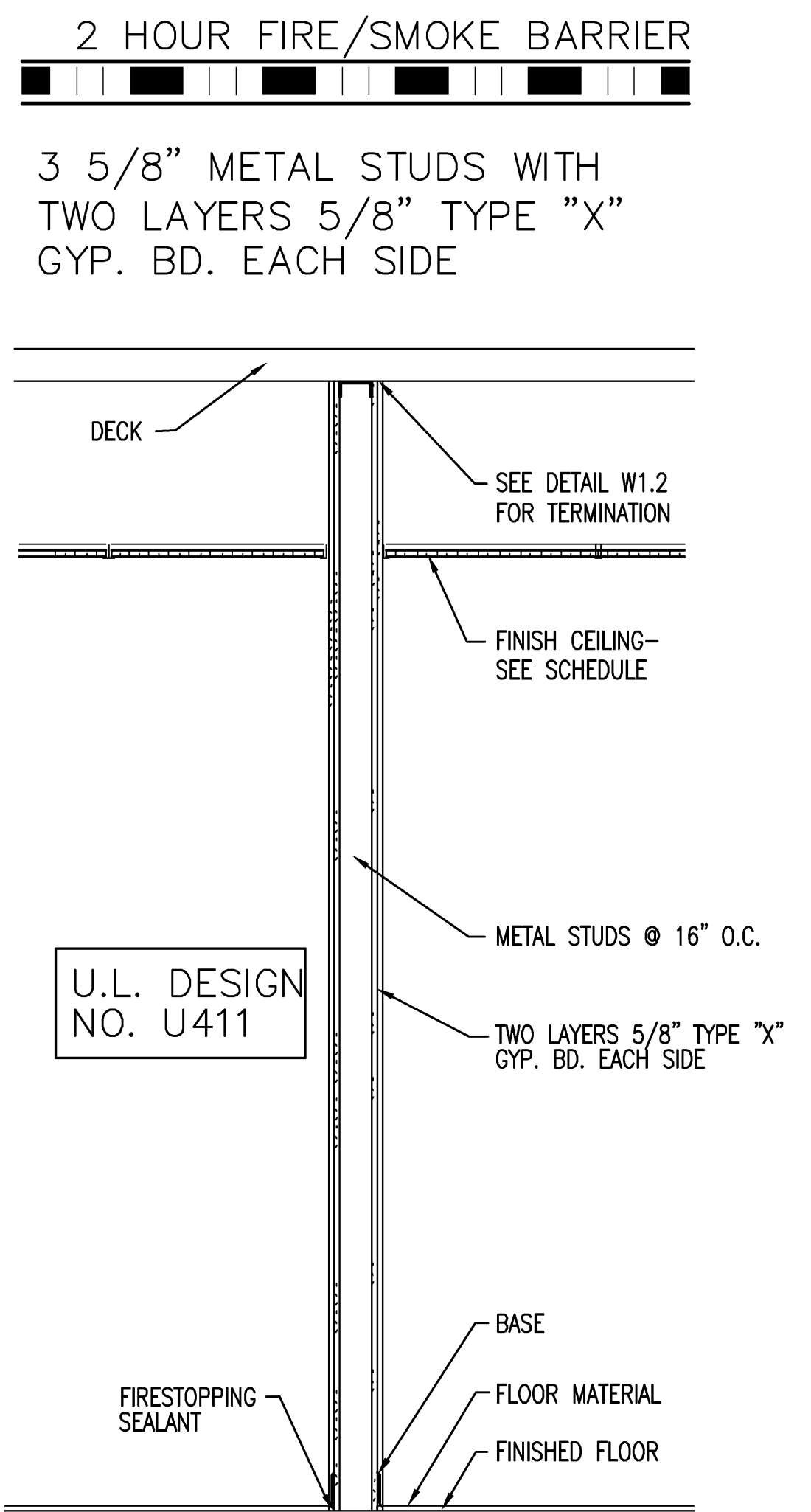

OVERALL PLAN

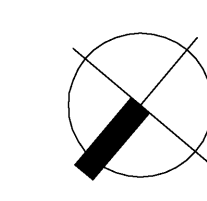

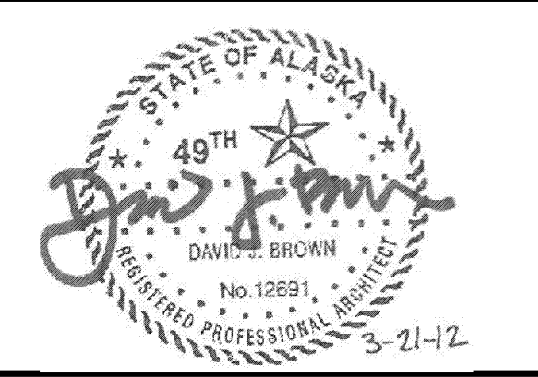
FIRST FLOOR PLAN PART A - DIMENSIONED

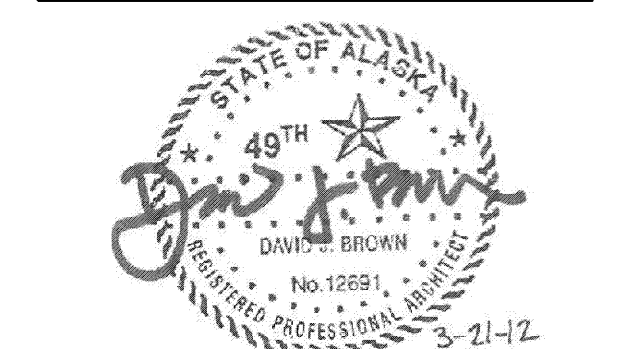


FIRST FLOOR PLAN PART B - NOTED

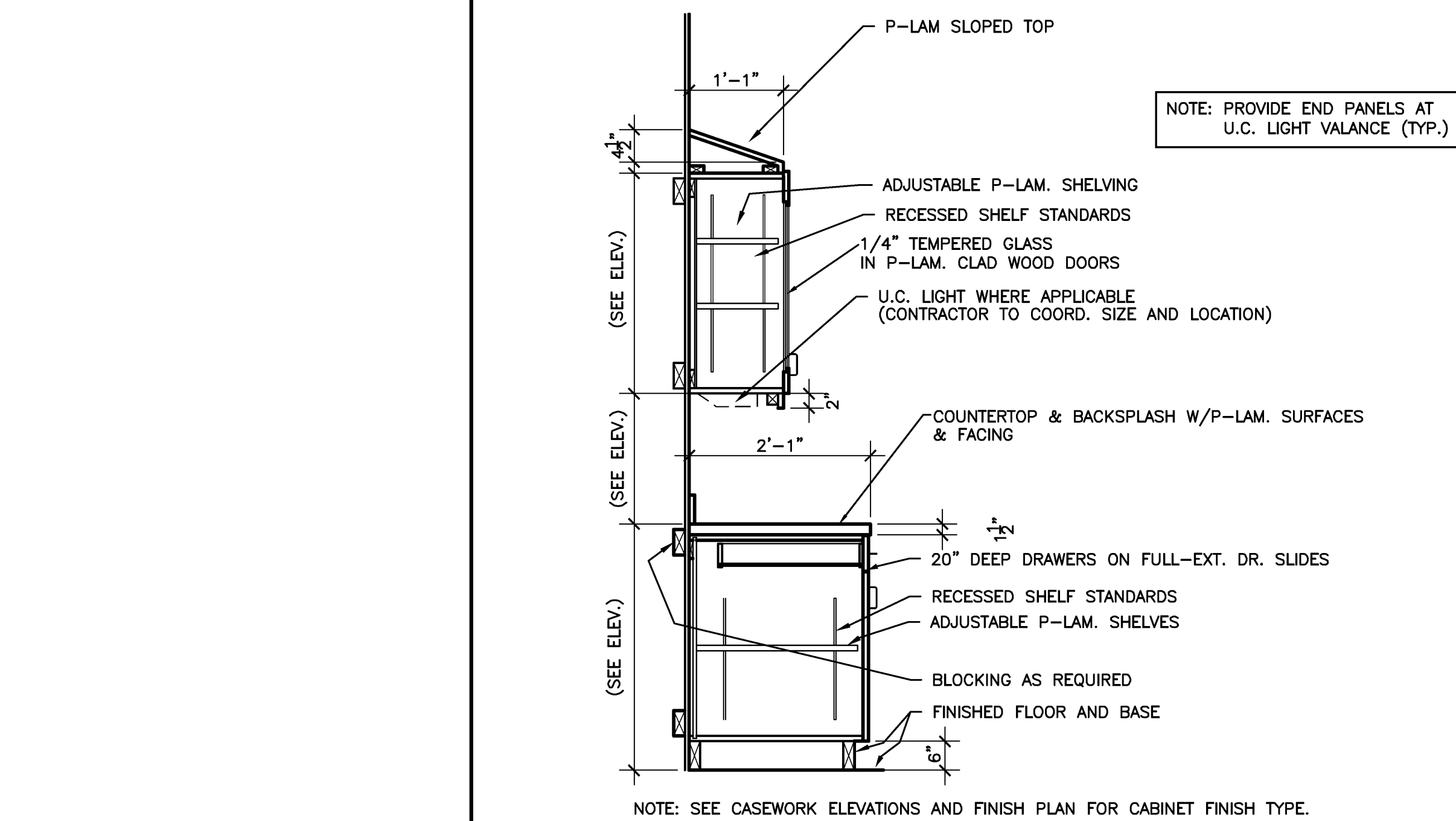
